# **Workplace Charging Challenge Pledge**

Building Commitment for Electric Vehicle Charging in America's Workplaces

On March 7, 2012, President Obama announced the *EV Everywhere Challenge*, a "Clean Energy Grand Challenge" with the goal of enabling the United States to be the first in the world to produce plug-in electric vehicles (PEVs) that are as affordable and convenient for the average American family as today's gasoline-powered vehicles within the next 10 years. To meet this challenge, the U.S. Department of Energy (DOE) is collaborating with American innovators to accelerate the development and commercialization of the next generation of PEVs and charging infrastructure.

The Workplace Charging Challenge will transform the way employers view their role in building the country's PEV charging infrastructure. Employer-provided PEV charging serves as an attractive employee benefit, enhances corporate sustainability efforts, and signals corporate leadership in adopting advanced technology. It also fills an important gap in America's PEV charging infrastructure, increasing consumer exposure and access to PEV charging opportunities.

# Workplace Charging Challenge Goal:

Increase the number of American employers offering workplace charging by tenfold in five years.

As part of the Workplace Charging Challenge, this Pledge calls upon America's employers to act as *Partners* and make a bold commitment to provide PEV charging

access to their workforce. This Pledge also enlists stakeholder organizations as **Ambassadors** to promote and facilitate workplace charging. In support of those who undertake the Pledge, DOE will provide resources and establish an information-sharing forum. Additionally, successes made by those who undertake the Pledge will be recognized through the identification of best practices.

**Partners** are employers that commit to assessing employee demand for PEV charging at the workplace, and developing and executing a plan to provide PEV charging access for employees. **Partners Pledge to:** 

#### Commit

- Name a primary contact and provide a senior level commitment to install workplace charging stations.
- Assess PEV charging demand at workplace and develop a plan within 6 months to deploy PEV charging
  infrastructure. Partner plans will include milestones for charging infrastructure installation with a minimum
  goal of provision of charging for a portion of PEV-driving employees at one or more major employer
  worksites, and a best practice goal of assessing and meeting all PEV-driving employee demand.

### Take Action

- Publicly announce within 6 months the implementation of a plan for the installation of workplace charging.
- Publicly highlight new and existing workplace charging installations.

#### Share Progress

• Share within 12 months and on an annual basis a narrative highlighting progress and additional steps to be taken toward meeting milestones set in the plan.

**Ambassadors** are stakeholder organizations that commit to developing and executing a plan to support and promote deployment of workplace charging infrastructure. **Ambassadors Pledge to:** 

#### Commit

 Name a primary contact and provide a senior level commitment to support and promote deployment of workplace charging infrastructure.

#### Take Action

• Develop and implement a plan within 3 months to support and promote the deployment of workplace charging infrastructure. Ambassador plans will include activities in which the Ambassador broadly encouraged workplace charging among its stakeholders.

#### Share Progress

• Share within 12 months and on an annual basis a narrative highlighting progress and additional steps to be taken toward meeting milestones set in the plan.

#### **DOE Pledges to:**

#### <u>Assist</u>

 Provide technical assistance to support the commitment by Partners and Ambassadors to workplace charging installation at private workplaces.

#### Connect

- Establish a network of Partners and Ambassadors to share best practices and lessons learned.
- Convene information exchanges with Partners and Ambassadors to bolster the development of workplace charging.

## **Recognize Success**

• Recognize best practices and lessons learned, to be shared through information exchanges, as well as through press releases and digital outreach.
